§ 1

The Bidder submits this declaration to the Receiver of Toya Development Sp. z o.o. Sp. k. in liquidation with its registered office in Kryniczno, declaring their interest in the purchase of the company in liquidation of its organized part to obtain information about the company and its individual components, preceding a potential bid to purchase the company or its organized part.

§2

1. The Bidder is obliged to maintain confidentiality and to not disclose to third parties any information obtained about Toya Development Sp. z o.o. Sp. k. in liquidation with its registered office in Kryniczno, in particular based on the review of documents and assets of the company, and also in relation to potential negotiations carried out to enter into an agreement concerning the purchase of the company, its organized part or particular assets of the company.
2. The prohibition of disclosing certain information does not include obligations of the Bidder:
 - a. arising from the regulations governing public trading in securities;
 - b. arising from the regulations and other cases provided for, in which the Parties will be required to disclose this information on the basis of:
 - (1) applicable legal provisions;
